

## ANNEX ONE

### SCHEDULE FOR THE WITHDRAWAL OF ISRAELI FORCES TO POSITIONS HELD BEFORE 28 SEPTEMBER 2000 AND LIFTING OF THE SIEGE

Israeli forces will withdraw from all Areas A and other Palestinian territories under Palestinian jurisdiction in accordance with agreements signed.

**Stage One:** First 48 Hours (two days) from adoption of this workplan

- Israeli forces will dismantle and remove all checkpoints bordering Areas A and other Palestinian territories under Palestinian jurisdiction in accordance with agreements signed which did not exist prior to September 28, 2000 without creating new positions. Israel will repair all damaged infrastructure resulting from the creation and management of the checkpoints.
- Israeli forces will allow the free and unimpeded movement of people and goods at any checkpoints in and bordering Area H2 as it existed prior to September 28, 2000.
- Israel will allow the free and unimpeded movement of people and goods at any checkpoints bordering Areas A and other Palestinian territories under Palestinian jurisdiction in accordance with agreements signed that existed prior to September 28, 2000.
- Israel will allow for the freedom of movement of people and goods through all crossing points with Egypt and Jordan, including the Gaza Airport and the Port of Gaza, in accordance with procedures and regulations existing on September 27, 2000. Palestinian security and other officials will return to duty at these crossing points in accordance with procedures and regulations existing on September 27, 2000.
- Palestinians employed in Israel prior to September 28, 2000 will be allowed to return to their jobs in accordance with procedures and regulations applied on September 27, 2000.

**Stage Two:** Next 72 hours (three days)

- Israeli forces will redeploy all its forces in all Areas B and other Palestinian territories under Palestinian jurisdiction in accordance with agreements signed to positions it held prior to September 28, 2000.
- Israeli forces will dismantle and remove all checkpoints in Areas B, and other Palestinian territories under Palestinian jurisdiction in accordance with agreements signed, which did not exist prior to September 28, 2000 without creating new positions. Israel will repair all damaged infrastructure resulting from the creation and management of the checkpoints.

- Israel will allow the free and unimpeded movement of people and goods at any checkpoints in Areas B and other remaining Palestinian territories under Palestinian jurisdiction in accordance with agreements signed which existed prior to September 28, 2000.
- Priority in the above will be given to the friction points attached.

**Stage Three:** Next 96 hours (four days)

- Israel will redeploy all its forces in Areas C, and all other remaining Palestinian positions, from positions which did not exist prior to September 28, 2000.
- Israeli forces will dismantle and remove all checkpoints in Areas C, and other remaining Palestinian positions for which Israel has security and administrative responsibility, which did not exist prior to September 28, 2000. Israel will repair all damaged infrastructure resulting from the creation and management of the checkpoints.
- Israel will allow the free and unimpeded movement of people and goods at any checkpoints in Areas C and other remaining Palestinian positions for which Israel has security and administrative responsibility which existed prior to September 28, 2000.
- Priority in the above will be given to the friction points attached.

**Stage Four:** Last 120 hours (five days)

- Israel will allow freedom of movement of people and goods from the West Bank and Gaza Strip into and through Israel and from Israel into and through the West Bank and Gaza Strip pursuant to procedures existing on September 27, 2000.
- Israel will allow freedom of movement of people and goods between the West Bank and Gaza Strip in accordance with the Protocol on Safe Passage.
- Palestinian officials holding "VIP" status will have full freedom of movement into and through Israel in accordance with arrangements applied on September 27, 2000.
