# Colonization and Nationalism: Jewish settlement in Palestine-Israel, 1882-1948

The seminar deals with the Jewish colonization in Palestine during the first half of the 20<sup>th</sup> century, focusing on issues relating to the interrelations between nationalism, immigration and colonization, such as: what distinguished the Zionist orchestrated settlement policy? To what extent did national settlement resemble imperial colonization? Did immigration dictate or had it been dictated by the national settlement policy? How much was the national enterprise involved with socialism? What where the mutual impacts between national colonization and the Arab-Jewish conflict? The seminar will be based on intensive individual readings of the students, and each session will be opened by students' presentations. Each student will have to submit by the end of the semester a seminar paper of about 20-30 pages (graduate) or 10-15 (undergraduate), which will be worked out under the guidance of the teacher.
