SUBJECT: Adol EICHMANN

15 June 1966

1. In order to assist you in your interrogation of Subject and for the preparation of your case in court, we have been ransacking the captured German documents (note: these are to be distinguished from the German Foreign Ministry documents now in the public domain and the Nuremberg War Crimes documents), for material relating to Subject. It is quite a formidable task, as there are something like over five miles of documents dealing with a variety of topics, principally routine military reports, which have never been properly classified or indexed.

2. Herewith we send you the first fruits of our search which consist of two parts--the first are photocopies of documents relating directly to EICHMANN, or in which he is mentioned by name, and the second photocopies of correspondence files of the SS Security Service covering its operations. These documents are frequently bound in dossiers and although some of the material may be inconsequential, we have photocopied the entire dossier when it deals with matters of concern to Abt II 112 to which EICHMANN belonged. It will be noted that in some of the files are inserted sheets in the English language indicating that certain documents have been microfilmed. These documents were removed for this purpose and handed over to the War Crimes Commission. At the present they cannot be located, but if there are any which appear to be of interest, we will try and locate them for you.
