



GENERAL INSTRUCTIONS: ALL POSTS SHOULD DRAW ON THE FOLLOWING DISCUSSION OF US POSITIONS AND OBJECTIVES AT THE 36TH UNGA WHICH STARTS SEPTEMBER 15 TO CONVEY US VIEWS ON KEY ISSUES AND TO ELICIT HOST GOVERNMENT VIEWS AND SUPPORT. EMBASSY LONDON SHOULD ALSO CONVEY US VIEWS TO HMG AS EC-10 PRESIDENT. PLEASE REPORT REACTIONS, INFO USUN, BY COB SEPTEMBER 4.
- 3. SETTING AND OBJECTIVES: THE 36TH UNGA TAKES PLACE AT A TIME WHEN U.S. RELATIONS WITH THE G-77 COUNTRIES ARE UNSETTLED. U.S. POSITIONS ON LAW OF SEA, GLOBAL NEGOTIATIONS, INFANT FORMULA, INFORMATION FLOW, THE

MIDDLE EAST, AND SOUTHERN AFRICA HIGHLIGHT OUR DISAGREEMENTS WITH G-77 DOGMA, AND GIVE THE SOVIETS MANY OPPORTUNITIES TO EXPLOIT WEST/SOUTH DIFFERENCES. THE SPECIAL SESSION ON NAMIBIA, WHICH WILL IMMEDIATELY PRECEDE THE GA, COUPLED WITH THE SCHEDULED VISIT TO THE US OF A SOUTH AFRICAN RUGBY TEAM, WILL OFFER FURTHER OPPORTUNITY TO CASTIGATE THE US. WITH THE POLISH SITUATION STILL IN THE NEWS, ANTI-SOVIET FEELING WIDESPREAD IN THE UN, THE US HAS MANY DIPLOMATIC CARDS TO PLAY.



FYI, IT IS IMPORTANT FOR POSTS TO RAISE THIS ISSUE IN ORDER TO ENSURE THAT THERE IS NO DOUBT ABOUT OUR POSITION. SOME POSTS MAY BE TOLD THAT THERE IS NO REASON TO FEAR A SERIOUS CHALLENGE AT THE GA. 

## B. PUERTO RICO.

FYI, ON AUGUST 20 THE UN DECOLONIZATION COMMITTEE (COMMITTEE OF 24) ADOPTED A RESOLUTION CALLING FOR PUERTO RICO TO BE PLACED ON THE AGENDA OF THE 1982 GENERAL ASSEMBLY. THIS IS HIGHLY OBJECTIONABLE TO US SINCE IT IGNORES PAST GA ACTION WHICH REMOVED PUERTO RICO FROM THE LIST OF NON-SELF-GOVERNING TERRITORIES. IT COULD OPEN THE WAY FOR A CONTENTIOUS INTERNATIONAL DEBATE ON PUERTO RICO, WHICH WE REGARD AS A PURELY DOMESTIC ISSUE. WE WILL ATTEMPT TO DEFLECT THIS PROPOSAL ON PROCEDURAL GROUNDS. END FYI.

- -- PUERTO RICO'S STATUS IS A PURELY DOMESTIC MATTER AND NOT A QUESTION FOR THE UN TO CONSIDER. WE REJECT AS ILLEGAL THE RECENT ATTEMPT BY THE COMMITTEE OF 24 TO PLACE PUERTO RICO ON THE AGENDA OF THE 1982 GENERAL ASSEMBLY.
- -- THE US FIRMLY SUPPORTS THE PRINCIPLE OF SELF-DETER-MINATION BECAUSE THEY ARE SELF-GOVERNING IT IS UP TO THE PEOPLE OF PUERTO RICO TO DECIDE AMONG THEMSELVES WHETHER AND HOW THEY WISH TO CHANGE THEIR POLITICAL STATUS, AND IT IS WHOLLY INAPPROPRIATE FOR THE UN OR ANY OTHER BODY TO INTERFERE IN THAT DECISION.
- -- WE CALL ON ALL COUNTRIES TO REJECT THIS UNWARRANTED AND ILLEGAL ATTEMPT TO INTERFERE IN THE INTERNAL AFFAIRS OF THE US AND PUERTO RICO. THE US WILL NOT UNDERSTAND THE POLICY OF ANY COUNTRY WHICH SUPPORTS THIS BLATANT AND UNFRIENDLY ACTION BY THE COMMITTEE OF 24. THE US WILL PAY PARTICULAR ATTENTION TO HOW EACH

# C. AFGHANISTAN.

FYI, WE WILL CONTINUE TO SUPPORT A STRONG RESOLUTION A? THE UNGA CALLING FOR A SETTLEMENT IN AFGHANISTAN AND A WITHDRAWAL OF SOVIET FORCES. WE WILL URGE PAKISTAN, WHOSE LEADERSHIP WILL AGAIN BE ESSENTIAL TO MAXIMIZE ISLAMIC AND NON-ALIGNED SUPPORT, TO PRESS FOR A TEXT THATSTRONGLY REAFFIRMS THE PRINCIPLES OF LAST YEAR'S RESOLUTION, I.E. TROOP WITHDRAWAL AND SELF-DETERMINATION, AND SUPPORTS ALL INITIATIVES THAT WOULD BRING ABOUT A PEACEFUL SETTLEMENT UNDER THE TERMS OF THE RESOLUTION. WE ALSO SUPPORT THE EC PROPOSAL FOR APOLITICAL CONFERENCE OUTSIDE THE UN FRAMEWORK. WE FAVOR SEPARATE ACTION TO BRING ABOUT AN INTERNATIONAL

CONFERENCE ON AFGHAN REFUGEES EARLY NEXTYEAR. THE SOVIETS HAVE FORMALLY REJECTED THE EC PROPOSAL, BUT THE EC APPARENTLY PLANS TO KEEP IT ON THE TABLE. IN ORDER TO ENSURE THE STRONGEST POSSIBLE NON-ALIGNED SUPPORT-FOR THE UNGA RESOLUTION, WE WILL NOT RECOMMEND LINKING THE EC PROPOSAL WITH THE RESOLUTION. END FYI

- -- A STRONG RESOLUTION ON AFGHANISTAN AT THE UNGA, EMPHASIZING THE NEED FOR SOVIET TROOP WITHDRAWAL AND SELF-DETERMINATION OF THE AFGHAN PEOPLE, AND AN UNDIMINISHED VOTE, ARE ESSENTIAL.
- -- A WEAKER RESOLUTION OR DECLINE IN SUPPORT WOULD BE A DEFEAT FOR ALL NATIONS WHO SUPPORT THE PRINCIPLES OF-SELF-DETERMINATION, INDEPENDENCE, AND NON-INTERVENTION.
- -- BROADLY SUPPORTED UNGA ACTION ON AFGHANISTAN IS



ESPECIALLY IMPORTANT, SINCE IT DEMONSTRATES THAT THE SOVIET INVASION AND MILITARY OCCUPATION OF AFGHANISTAN IS AN INTERNATIONAL ISSUE OF CRUCIAL IMPORTANCE TOALL NATIONS, ALIGNED AND NON-ALIGNED.

- -- WE WELCOME THE EC INITIATIVE FOR AN INTERNATIONAL POLITICAL CONFERENCE ON AFGHANISTAN THAT WOULD WORK TOWARD RESTORATION OF A NON-ALIGNED, INDEPENDENT AFGHANISTAN. WE HOPE THE SOVIET UNION WILL RECONSID
- ER ITS REJECTION OF THIS PROPOSAL.
- D. KAMPUCHEA. WE HOPE THAT THE GREAT MAJORITY OF UN MEMBERS.



- -- THE CONFERENCE SHOWED STRONG INTERNATIONAL SUPPORT FOR A SETTLEMENT OF THE KAMPUCHEAN PROBLEM IN ACCORDANCE WITH THE TERMS OF PREVIOUS UNGA RESOLUTIONS AND THE DECLARATION ADOPTED BY THE CONFERENCE. THE CONFERENCE STRONGLY REPUDIATED THE OCCUPATION AND CONTROL OF AN INDEPENDENT COUNTRY BY THE MILITARY FORCES OF ANOTHER. AT THE SAME TIME, IT OFFERED AN APPROACH FOR A NEGOTIATED SETTLEMENT THAT WE HOPE VIETNAM WILL EVENTUALLY ACCEPT. RENEWED ACTION BY THE UNGA ON KAMPUCHEA WILL REINFORCE THE RESULTS AT THE CONFERENCE.
- -- THERE MIGHT BE A CHALLENGE TO THE CREDENTIALS OF THE REPRESENTATIVE OF DEMOCRATIC KAMPUCHEA (DK) BY THE VIETNAMESE AS THERE WAS IN THE PREVIOUS TWO UNGAS.
- -- THE US SUPPORTS THE CREDENTIALS OF THE DK ON THE NARROW TECHNICAL GROUNDS THAT THAT REGIME WAS THE LAST GOVERNMENT OF KAMPUCHEA TO BE RECOGNIZED BY THE UN AND CAN LOSE ITS CREDENTIALS ONLY IF THERE IS A SUPERIOR CLAIMANT.
- -- THE HENG SAMRIN REGIME IS NOT SUCH A CLAIMANT BECAUSE IT IS THE CREATION OF AND IS MAINTAINED IN POWER BY THE VIETNAMESE OCCUPATION FORCES OF 180,000 TROOPS.
- -- OUR STAND ON THIS QUESTION DOES NOT IMPLY APPROVAL OF THE HORRENDOUS MISRULE AND MASSIVE HUMAN RIGHTS VIOLATIONS OF THE POL POT REGIME NOR DOES IT MEAN THAT THE US WOULD BE WILLING TO ACCEPT THE RETURN TO



E. MIDDLE EAST

FYI, THE CAMP DAVID PROCESS WILL FACE A HEAVY ARAB/PLO

DIPLOMATIC ASSAULT IN THE 36TH UNGA. THE MAIN ELEMENTS OF THE ARAB/PLO STRATEGY, APART FROM A POSSIBLE DIRECT CHALLENGE TO ISRAEL'S PARTICIPATION IN THE UNGA, WILL PROBABLY BE (A) A CALL FOR REPLACEMENT OF UNSC RESOLUTION 242 WITH A NEW UNSC RESOLUTION RECOGNIZING THE NEED FOR A PALESTINIAN STATE, (B) INTENSIFIED ATTACKS ON THE CAMP DAVID ACCORDS, AND (C) AN EFFORT TO CENSURE ISRAEL FOR THE RAIDS ON IRAQ AND LEBANON. END FYI.

- -- WE ARE COMMITTED TO THE SUCCESS OF THE PROCESS BEGUN AT CAMP DAVID. WE WILL DO ALL WE CAN THROUGH THIS PROCESS TO ACHIEVE A JUST AND LASTING MIDDLE EAST SOLUTION.
- -- WE ARE OPPOSED TO ONE-SIDED UNGA RESOLUTIONS OF THE TYPE ADOPTED LAST YEAR UNDER THE AGENDA ITEMS CALLED "THE QUESTION OF PALESTINE" AND "THE SITUATION IN THE MIDDLE EAST." SUCH RESOLUTIONS DO NOT HELP THE PEACE PROCESS; IN FACT, THEY WORK AGAINST THE POSSIBILITY OF REAL PROGRESS TOWARD PEACE. -- WE WERE PARTICULARLY DISAPPOINTED WITH THE RESOLUTION LAST YEAR THAT ATTEMPTED TO UNDERMINE RESOLUTION 242, WHICH REMAINS THE BASIS FOR PEACE IN THE MIDDLE EAST, AND THE RESOLUTION ATTACKING THE EGYPT-ISRAEL PEACE TREATY.
- -- THE SECURITY COUNCIL HAS CONSIDERED THE RECENT ISRAELI RAIDS ON IRAQ AND LEBANON. WE MADE OUR POSITIONS KNOWN ON THESE ISSUES IN THAT FORUM. ANY UNGA ACTION ON THESE QUESTIONS SHOULD AIM AT HELPING THE CAUSE OF PEACE, AND STRENGTHENING THE PRESENT CEASEFIRE, NOT AT INFLAMING THE PASSIONS AROUSED BY THE RAIDS.

# F. SOUTHERN AFRICA

FYI, US POLICY IN SOUTHERN AFRICA IS BASED ON A FIRM COMMITMENT TO INDEPENDENCE FOR NAMIBIA AND PEACEFUL EVOLUTIONARY CHANGE AWAY FROM APARTHEID IN SOUTH AFRICA. TO ACHIEVE THESE GOALS THE ADMINISTRATION HAS SOUGHT TO CREATE A FAVORABLE CLIMATE FOR DISCUSSIONS: ESTABLISHING A DIALOGUE, ENDING PUBLIC CRITICISM AS A MEANS OF GAINING PRIVATE INFLUENCE, AND REVERSING EFFORTS TO ISOLATE SOUTH AFRICA IN ORDER TO CHANGE SAG POLICY. OUR POSITIONS ON THESE ISSUES IN INTERNATIONAL FORUMS ARE DESIGNED TO MAXIMIZE USLEVERAGE IN BOTH THE NAMIBIA AND INTERNAL SOUTH AFRICA CONTEXTS.

ON NAMIBIA, THE US, AS A MEMBER OF THE WESTERN CONTACT GROUP, HAS CONTINUED EFFORTS TO BRING ABOUT

INDEPENDENCE OF THAT TERRITORY IN ACCORDANCE WITH SECURITY COUNCIL RESOLUTION 435IN A MANNER THAT WILL COMMAND INTERNATIONAL APPROVAL. WITH THE OTHER MEMBERS OF THE CONTACT GROUP, THE US IS PRESENTLY CONSIDERING MEANS TO GET THE STALLED NEGOTIATIONS BACK ON TRACK, WHICH MAY INCLUDE ADDITIONAL MEASURES TO STRENGTHEN THE EXISTING UN PLAN AND PROVIDE THE CONFIDENCE NECESSARY FOR ALL PARTIES TO PROCEED. END FYI.

- -- THE US HAS PUBLICLY REITERATED ITS ABHORRENCE OF APARTHEID AND THE NECESSITY FOR EVOLUTIONARY CHANGE IN SOUTH AFRICA.
- -- THE US WILL SUPPORT THOSE WITHIN SOUTH AFRICA WHO ARE



WORKING FOR CONSTRUCTIVE CHANGE THROUGH PEACEFUL MEANS. WE DO NOT SUPPORT THOSE WHO ADVOCATE VIOLENT CHANGE, OR WHO UNDERTAKE TERRORIST ACTIONS TO ACHIEVE THEIR GOALS.

- -- DIALOGUE WITH SOUTH AFRICA, RATHER THAN ISOLATION, REPRESENTS THE BEST MEANS FOR THE US TO HAVE SOME INFLUENCE OVER THE DIRECTION OF SAG POLICY ON APARTHEID AND NAMIBIA.
- -- ON NAMIBIA, WE CONTINUE TO WORK TOWARD AN INTERNATIONALLY ACCEPTABLE SETTLEMENT BASED ON THE UN PLAN. OUR RECENT INITIATIVES HAVE FOCUSSED ON MEASURES TO ASSURE ALL PARTIES THAT AN INDEPENDENT NAMIBIA WILL BE A STABLE, DEMOCRATIC REGIME FOLLOWING THE TRANSITION PROCESS.



THE LATIN ·AMERICANS MAY TRY TO OFFER THEIR OWN CANDIDATE, ALTHOUGH PROSPECTS FOR AGREEMENT AMONG THEM ON ONE CANDIDATE ARE NOT GOOD. THE GENERAL ASSEMBLY ELECTS THE SECRETARY GENERAL "ON THE RECOMMENDATION OF THE SECURITY COUNCIL", WHICH MEANS THAT THE VETO APPLIES AND THAT THE ELECTION WILL HINGE

ULTIMATELY ON AGREEMENT AMONG THE PERMANENT - MEMBERS. WE WOULD BE INTERESTED IN INFORMATION YOU MAY PICK UP ON THIS TOPIC. END FYI.

-- WE HAVE NOT YET TAKEN A POSITION ON ANY OF THE KNOWN OR POTENTIAL CANDIDATES FOR UNSYG. THE - ELECTION WILL NOT TAKE PLACE UNTIL LATER IN THE SESSION, AND WE WANT TO DEFER ANY COMMITMENT ON THE SYG ELECTION UNTIL IT IS CLEAR WHO ALL THE - CANDIDATES ARE.

THE POSSIBILITY OF A COMPROMISE ARAB CANDIDATE-IF THE ARABS CANNOT REACH A CONSENSUS. KOH WOULD BE BETTER FOR US, BUT KAISER WOULD BE ENTIRELY -ACCEPTABLE. END FYI.



#### C. SECURITY COUNCIL EXPANSION

ALTHOUGH THE OTTAWA DECLARATION AND THE PRESS RELEASE FOLLOWING THE CANCUN PREPARATORY MEETING APPEAR TO SUGGEST A QUALIFIED US ENDORSEMENT OF GNS, THIS IS NOT OUR POSITION. WE HAVE NOT CLOSED THE DOOR ON GNS, BUT WE DOUBT THAT IT WOULD SERVE ANY REAL ECONOMIC PURPOSE THAT COULD NOT BETTER -BE ACHIEVED THROUGH EXISTING INSTITUTIONS OR BY OTHER MEANS. THE USG OBJECTIVE IS TO: REASSERT LEADERSHIP IN RELATION TO THE DEVELOPMENTOF OUR CARIBBEAN BASIN POLICY IS INDICATIVE OF THE WORKING OUT OF THAT OBJECTIVE.

NEGOTIATIONS IN NEW YORK THROUGHOUT 1980 SUGGEST THAT SUCH AN AGREEMENT MAY NOT BE POSSIBLE. IN ANY CASE, WHILE WE HAVE NOT CLOSED THE DOOR ON GNS, WE ARE NOT CONVINCED AT THIS TIME THAT IT WOULD SERVE ANY REAL ECONOMIC PURPOSE THAT COULD NOT BETTER BE ACHIEVED BY OTHER MEANS.

#### E. ARMS CONTROL

FYI, THE USG IS PRESENTLY REVIEWING ARMS CONTROL AND OTHER DEFENSE-RELATED ISSUES. THESE REVIEWS WHICH ARE NOT YET COMPLETED, MAY WELL PREVENT US FROM TAKING DEFINITE POSITIONS ON A GREAT MANY OF THE ISSUES UNDER REVIEW IN NEW YORK AND WILL REQUIRE A CAUTIOUS US APPROACH. PREPARATIONS FOR, AND THE DISCUSSION OF THE SECOND SPECIAL SESSION ON DISARMAMENT, SCHEDULED FOR LATE SPRING 1982, WILL ALSO INFLUENCE FIRST COMMITTEE DEBATE. FOR



THE US THE MOST CONTENTIOUS SUBJECTS LIKELY TO COME UP AT THE GA INCLUDE: THE COMPREHENSIVE TEST BAN (CTB), THE NEW SOVIET INITIATIVE TO BAN ALL WEAPONS FROM OUTER SPACE, A UN-CONDUCTED INVESTIGATION OF ALLEGATIONS OF USE OF CHEMICAL WEAPONS IN AREAS SUCH AS AFGHANISTAN, LAOS AND KAMPUCHEA, AND BECAUSE OF THE ISRAELI RAID ON IRAO, THE QUESTION OF NUCLEAR WEAPONS IN THE MIDDLE EAST. END FYI.

-- WE WILL ATTEMPT, IN GENERAL, TO KEEP DEBATE ON ARMS CONTROL AT THE GA AS CONSTRUCTIVE AND NON-CONTENTIOUS AS POSSIBLE. WE WILL VOTE AGAINST THOSE RESOLUTIONS THAT ARE CLEARLY UNACCEPTABLE, E.G. (DEPENDING ON THE EXACT WORDING) ON CTB, THE NON-STATIONING OF NUCLEAR WEAPONS, AND THE NON-INCREASE

OF ARMAMENT BY THE UNSC PERMANENT MEMBERS; WEWILLABSTAIN ON OTHERS, E.G. THE AFRICAN AND LATIN AMERICAN NUCLEAR FREE ZONES, A BAN ON NEW WEAPONS OF MASS DESTRUCTION; AND FAVOR STILL OTHERS, E.G. ABUSES IN CLOSED SOCIETIES (FOR EXAMPLE, PSYCHIATRIC ABUSE), THOUGH HARDER TO DOCUMENT PRECISELY BECAUSETHEY ARE CLOSED, MUST BE ADDRESSED.

-- THE UNGA WILL HAVE BEFORE IT A LONG-AWAITED DRAFT DECLARATION AGAINST RELIGIOUS INTOLERANCE, WHOSE ADOPTION WILL BE A SIGNAL ACHIEVEMENT. WE STRONGLY URGE YOU TO JOIN IN SUPPORTING THIS DECLARATION. - (FYI: THE SOVIETS ARE OPPOSED AND MAY SUGGEST FURTHER STUDY IN ORDER TO AVOID FINAL ADOPTION).

#### G. INFORMATION FLOW.

FYI, UNGA AGENDA ITEM 67 "QUESTIONS RELATING TO INFORMATION"WILL BE CONCERNED PRIMARILY WITH CONSIDERATION OF A DRAFT RESOLUTION BASED ON THE REPORT OF THE 57 MEMBER UNGA COMMITTEE ON INFORMATION. # H. WESTERN SAHARA

FYI, AT THE OAU CHIEFS OF STATE SUMMIT IN JUNE, KING HASSAN OF MOROCCO ACCEPTED THE PRINCIPLE OF A "CONTROLLED REFERENDUM" AMONG THE PEOPLES OF THE WESTERN SAHARA AS A MEANS OF RESOLVING THE PRESENT DISPUTE. AN OAU IMPLEMENTATION COMMITTEE COMPOSED OF THE HEADS OF STATE OF GUINEA, SUDAN, NIGERIA,

KENYA, SIERRA LEONE, MALI, AND TANZANIA CONVENED IN NAIROBI TO DISCUSS THE ISSUE. AT PRESENT, THE OAU EXPECTS THAT THE UN WILL ASSUME RESPONSI-BILITY FOR MONITORING A REFERENDUM. THE MOROCCANS, THE ALGERIANS, AND THE POLISARIO DISAGREE ON A NUMBER OF MAJOR POINTS, INCLUDING THE POPULA-TION TO BE INCLUDED IN THE REFERENDUM (POLISARIO CLAIMS THAT MOST REFUGEES IN ALGERIA ARE ACTUALLY SAHAROUIS), AND THE PRESENCE OF MOROCCAN TROOPS IN THE TERRITORY DURING A REFERENDUM. LAST YEAR IN THE UNGA FOURTH COMMITTEE, A RESOLUTION FAVORABLE TO THE POLISARIO CALLING FOR THE WITHDRAWAL OF MOROCCAN TROOPS FROM THE TERRITORY WAS ADOPTED AND APPROVED BY THE GENERAL ASSEMBLY. THE MOROCCAN RESOLUTION WAS NARROWLY DEFEATED IN THE FOURTH COMMITTEE. END FYI.

- -- THE UNITED STATES IS FULLY SUPPORTIVE OF A PEACEFUL RESOLUTION OF THE WESTERN SAHARA QUESTION.
- -- BUILDING ON KING HASSAN'S AGREEMENT TO A REFERENDUM IN THE TERRITORY AS THE BASIS FOR AN ACT OF SELF-DETERMINATION, THE US HOPES THAT THIS YEAR THE GENERAL ASSEMBLY WILL ACCEPT A RESOLUTION HIGH-LIGHTING THE POSITIVE STEPS TAKEN BY PARTIES TO THE

## I. INDIAN OCEAN ZONE OF PEACE

FYI, FOLLOWING UNGA ADOPTION IN 1971 OF A RESOLUTION WHICH, IN ESSENCE, CALLED FOR THE GREAT POWERS TO REMOVE THEIR NAVAL FORCES AND FACILITIES FROM THE INDIAN OCEAN, THE UNITED STATES INDICATED THAT THE IOZP CONCEPT AS FORMULATED CONFLICTED NOT ONLY WITH THE RECOGNIZED RIGHTS OF TRANSIT AND OVERFLIGHT OF INTERNATIONAL WATERS BUT WITH THE INHERENT RIGHT OF SELF-DEFENSE OF STATES AS RECOGNIZED BY THE UN AD HOC COMMITTEE. WHEN THE US FINALLY JOINED AN EXPANDED AD HOC COMMITTEE IN 1980, WE MADE CLEAR THAT WE WOULD PRESS FOR CHANGE IN THE COMMITTEE'S WE HAVE CONSISTENTLY OPPOSED THE CONVENING OF AN IOZP CONFRENCE, GIVEN THE SOVIET OCCUPATION OF AFGHANISTAN (BY DEFINITION A "HINTERLAND" STATE OF THE IOZP) AND THE LACK OF AGREEMENT ON THE BASIC PRINCIPLES THAT SHOULD GOVERN AN IOZP. HOWEVER, THE NON-ALIGNED HAVE TABLED A DRAFT CALLING FOR AN IOZP CONFERENCE "NOT LATER THAN 1983" AND A "HIGH-LEVEL POLITICAL MEETING" TO COMPLETE ARRANGEMENTS FOR THE CONFERENCE. END FYI

-- WE ARE COMMITTED TO THE GOALS OF SECURITY AND STABILITY IN THE INDIAN OCEAN AREA AND WILL CONTINUE TO ADDRESS THESE ISSUES SERIOUSLY - HOWEVER, WE FIRMLY OPPOSE THE 1971 IOZP CONCEPT. WE HAVE MADE OUR RESERVATIONS CLEAR FROM THE BEGINNING OF THE IOZP PROCESS AND HAVE REEMPHASIZED THEM SINCE JOINING THE AD HOC COMMITTEE. A REDUCTION OF US AND

WESTERN NAVAL FORCES IN THE INDIAN OCEAN, EVEN IF BALANCED BY RECIPROCAL SOVIET REDUCTIONS, WOULD LEAVE THE USSR WITH THE PREPONDERANCE OF MILITARY POWER IN THE REGION, BASED ON ITS LAND AND AIR FORCES IN SOVIET CENTRAL ASIA AND AFGHANISTAN.

-- WE CONTINUE TO OPPOSE THE SETTING OF A DATE FOR AN IOZP CONFERENCE OR A HIGH-LEVEL PREPCOM UNTIL THERE IS A CONSENSUS OR A MORE REALISTIC IOZP CONCEPT AND A SOVIET WITHDRAWAL FROM AFGHANISTAN. WE ARE PREPARED, NEVERTHELESS, TO LOOK AT OTHER SUGGESTED APPROACHES TO THE AD HOC COMMITTEE'S WORK IN THE FUTURE.

#### J. CYPRUS

FYI, ALTHOUGH IT IS BY NO MEANS CLEAR THAT THE TURKISH CYPRIOT OFFER, MADE AUGUST 5, TO RETURN, AS PART OF AN OVERALL SETTLEMENT, A PORTION OF THE TERRITORY THEY NOW OCCUPY WILL CAUSE THE INTERCOMMUNAL TALKS TO TAKE OFF, IT DOES SUBSTANTIALLY INCREASE THE CHANCES FOR SERIOUS NEGOTIATIONS TO BEGIN AT IT WOULD, THEREFORE, BE PREFERABLE THAT THE TALKS NOT BE DIST; RBED BY EXTRANEOUS INFLUENCES SUCH AS A UNGA DEBATE AND VOTE ON A RESOLUTION WHICH COULD ONLY CAUSE A BITTER EXCHANGE BETWEEN THE CONTENDING PARTIES. WE HOPE TO CONVINCE THE GREEK CYPRIOTS THAT THE EXISTENCE OF THE TURKISH CYPRIOT PROPOSAL SHOULD CAUSE THEM TO PUT OFF UNGA DEBATE FOR ANOTHER YEAR. SHOULD THE GREEK CYPRIOTS, DESPITE OUR EFFORTS, INSIST ON DEBATE, WE WILL TRY TO SECURE AN ANODYNE RESOLUTION. END FYI.

-- WE CONTINUE TO BELIEVE THAT THE BEST APPROACH TO UNGA TREATMENT OF CYPRUS THIS YEAR IS TO DEFER DEBATE AS HAPPENED LAST YEAR.



FYI: THE 36TH UNGA WILL VOTE TO RELOCATE THE VOLUNTARY FUND FOR THE UN DECADE FOR WOMEN FROM NEW YORK TO VIENNA. THE FUND'S UMBRELLA ORGANIZATION, THE CENTER FOR SOCIAL DEVELOPMENT AND HUMANITARIAN AFFAIRS (CSDHA) WAS MOVED TO VIENNA IN 1979 BUT THE 34TH; NGA VOTED TO RETAIN THEFUND IN NEW YORK AND RECONSIDER THE ISSUE AT THIS SESSION. END FYI.

- -- ALTHOUGH IN MOST CIRCUMSTANCES IT IS DESIRABLE TO HAVE ALL COMPONENTS OF A UN ORGANIZATION LOCATED IN THE SAME PLACE, IN THIS CASE WE BELIEVE THE ARGUMENTS FOR KEEPING THE FUND IN NEW YORK OUTWEIGH OTHER CONSIDERATIONS.
- -- THE ASSISTANCE PROVIDED BY THE 'NDP IN COORDINATING PROJECT PROPOSALS, DISBURSING FUNDS, AND MONITORING PROGRESS AT THE COUNTRY LEVEL IS A CENTRAL ELEMENT OF THE FUND'S SUCCESS. WE DO NOT BELIEVE THIS EFFECTIVE ARRANGEMENT, WHICH PERMITS A CONSIDERABLE SAVINGS OF ADMINISTRATIVE COSTS, COULD BE MAINTAINED BY CORRESPONDENCE.
- -- A MOVE TO VIENNA WOULD SERIOUSLY DISRUPT THE FUND'S ACTIVITIES, J;ST AS INITIALLY A CONSIDERABLE TIME ELAPSED BEFORE IT BECAME FULLY EFFECTIVE IN NEW YORK.
- -- SINCE THE FUND WAS ESTABLISHED TO OPERATE FOR ALIMITED PERIOD, WE DO NOT BELIEVE THE ADDITIONAL
