Educated in Austria.

1927- salesman for the firm Vacuum ^{Oil} & Sil Comp.

1931- joined Austrian National Party.

1933-escaped to Germany and trained in Passau in Austrian Legion.

1934 -sergeant SD.

1937- on mission in Palestine.

1939, Jul. 26. Eichmann with the rank of captain set office

in Prague for Jewish Emigration. Belonged to Heydrich Security

Service in spite of special Goring mandat of Jan 24.

1941 Oct .29 promoted to Lt. Colonel .Head 4.A and 4b. RSHA.

1942-44 . Friendship with the Mufti.
