QUOTE:

THE SC,

HAVING EXAMINED THE COMPLAINT ON THE VIOLATION OF THE SOVEREIGNTY OF THE ARGENTINE REPUBLIC, RESULTING FROM THE TRANSFER OF ADOLF EICHMANN TO THE TERRITORY OF ISRAEL;

MINDFUL OF THE UNIVERSAL CONDEMNATION OF THE PERSECUTION OF THE JEWS UNDER THE NAZIS, AND OF THE CONCERN OF PEOPLE IN ALL COUNTRIES, AND ESPECIALLY IN ISRAEL, THAT EICHMANN SHOULD BE BROUGHT TO TRIAL FOR THE CRIMES OF WHICH HE IS ACCUSED;

DEPLORING THE VIOLATION OF ARGENTINE SOVEREIGNTY WHICH HAS OCCURRED;

RECIPIENT OF THIS MESSAGE IS RESPONSIBLE FOR THE MAINTENANCE RECORD OF THE INFORMATION DISSEMINATED THEREIN

NOTING THAT THE REITERATION OF ACTS LIKE THE ONE ORIGINATING THIS SITUATION WOULD IMPLY A BREACH OF THE PRINCIPLES UPON WHICH INTERNATIONAL ORDER IS BASED, CREATING A CLIMATE OF INSECURITY AND DISTRUST INCOMPATIBLE WITH THE PRESERVATION OF PEACE;

1. AFFIRMS THAT THE RECIPROCAL RESPECT AND MUTUAL SAFEGUARD OF THE SOVEREIGN RIGHTS OF STATES CONSTITUTE ESSENTIAL CONDITIONS FOR THEIR HARMONIOUS LIVING TOGETHER;
2. REQUESTS THE GOVTS OF ARGENTINA AND ISRAEL TO DETERMINE THE QUESTION OF APPROPRIATE REPARATION BY THE LATTER IN SUCH A WAY AS WILL HELP TO REESTABLISH THEIR TRADITIONALLY FRIENDLY RELATIONS.
