Prisoners

West Bank

- Mahmoud Abu Hanudch
 - still in custody; not yet convicted
 - allegedly headed military section of Hamas
 - arrested in July 2000; in jail - Nablus
 - never released
- Ibrahim Ghaneimat
 - ~~name~~ names removed from FBI list → shd. be reviewed
 - Sarif cell allegation → actually informant
 - in custody for protection → not in jail - Hebron
- Amjad Hinawi
 - arrested in 1996;
 - convicted in 1998 ^{Shalil} ~~Shalil~~ al-sharaf
 - part of cell that committed attack agst Bet El
 - → driver
 - 10 years ^{sentence} ~~imprisonment~~ ^{served} 6 years of imprisonment; now has } now in Nablus
furlough rights - 3 days/month } was in Jericho
 - no indication of criminal activity
 - Americans present when he was sentenced (head of Political Section at consulate)
- Mohammed al Wardah
 - still in Jericho prison; never been released
 - 25 year sentence
 - recruited 3 of suicide bombers in 1996
 - arrested in 1996; convicted shortly thereafter

Abd al Majid Dudin

- still imprisoned in Hebron
- arrested in 1995; ~~convicted~~ 12 year sentence
- up for parole
- gave shelter to Hassan Salameh, who caused most Israeli casualties

- involved in Hamas military ^{"issues"} activities + incitement
- released by Israelis in 1995; Israelis asked PA to arrest him 1 hour later
- no evidence against him at present
- arrested for incitement 1 month ago - speech agst. Israel + PA

How to help security co-op?

- 3d party v. important

- must be CIA

- this stopped since Bush; no longer allowed b/w parties

- 2-3 months ago, after Arafat-Powell

- 1 bilateral mtg since last mtg. w/ Abed;
US refused to participate - ^{too} detailed

- This week, serious review being conducted
 - Powell - Tenet say more involvement
 - DOD says no
- Amed believes there will be more involvement, but unsure how much
- unlikely to be political involvement or detailed

How was CIA helpful?

- Israelis provide list. CIA + Pals sit together + discuss case by case. Then wd. return to Israelis. Israelis gave CIA no evidence whatsoever.

[security section in Wye] ^{memo} was agreed before Wye. Talks not on security; political.]

→ monitoring is what's called for in future;
 "we will agree immediately if monitoring is part of the package. We want someone to say whether the allegations are true."

principles to overcome situation

- 2nd step: build trust gradually

- simultaneous unilateral steps
