1. AT HER REQUEST, I CALLED ON PRIMIN MEIR AT 12:30 TODAY. ALSO PRESENT WERE MORDECHAI GAZIT, DIRGEN IN PRIMIN'S OFFICE AND DCM.

2. THE PRIMIN INITIATED CONVERSATION BY EXPRESSING HER GREAT CONCERN ABOUT POSSIBILITY FOR QUCCK EXCHANGE OF POWS, NOTING THIS COULD BE MAJOR ITEM IN OPPPOSITION (LIKUD ATTACK) AGAINST GOVERNMENT IN KNESSET MEETING SCHEDULED FOR 6:00 PM TODAY. I FORTUNATELY WAS ABLE TO HAND HER COPY OF MCCLOSKEY'S STATEMENT (STATE 208876) WHICH SHE READ WITH GREAT RELIEF AND APPRECIATION NOTING "CH. GOOD: IV'VE BEEN WORRIED ABOUT THIS ALL MORNING." SHE GAVE INSTRUCTIONS THAT THE STATEMENT BE FEATURED ON ISRAEL RADIO THROUGH THE DAY.

3. SHE CONTINUED FOR AWHILE ON THE SUPJECT OF DOMESTIC POLITICAL SITUATION NOTING THAT THE OPPOSITION WILL NOT ACCEPT THE CEASEFIRE AND INDEED MAY MAKE THE ISSUE A VOTE OF CONFICENCE THIS AFTERNOON. SHE WAS SURE OF WINNING A MAJORITY VOTE ENDORSING THE GOVT'S ACCEPTANCE OF THE CEASEFIRE BUT THE PARLIAMENTARY DEBATES WOULD SHOW THAT THERE WAS CONSIDERABLE OPPCSITION TO THE GOVT'S ACTION.

4. MRS MEIR THEN EXPRESSED HER GREAT APPRECIATION FOR THE SECRETARY'S VISIT YESTERDAY. SHE NOTED THAT HER CONVERSATION WITH THE SECRETARY HELPED TO CLEAR UP SOME THINGS THAT WERE OBSCURED BY THE SPEED WITH WHICH EVENTS PROCEEDED. SHE REPEATED SEVERAL TIMES HER SATISFACTION WITH THE RESULTS OF THE VISIT.

5. I NOTED THAT THE BRITISH AMB HAD JUST CALLED ON ME AND, INTER ALIA, WAS PROBING FOR INFORMATION CONCERNING HIS "IMPRESSION" THAT THE GOI AND US MIGHT HAVE SOME MAJOR DIF-FERENCES OVER THE UN RESOLUTION. I ASSURED HER THAT I HAD DIASEUSED HIM OF ANY SUCH NOTION AT WHICH POINT MRS MEIR REMARKED "IT'S TOO BAD YOU COULDN'T HAVE MADE HIM HAPPIER."

VARIETY OF REASONS IN THE FIRST FEW HOURS AFTER A CEASEFIRE.

(THE MFA TOOK THE SAME POSITION WHEN WE QUERIED THEM ON THIS SUBJECT LAST NIGHT AT 10:00 P.M.). 9. MRS. MEIR WONDERED ALOUD "WHAT DO THE RUSSIANS DO WITH THE EGYPTIANS NOW?" I ASKED IF SHE THOUGHT THE RENEWED GROUND HOSTILITIES IN THE SOUTH REPRESENTED A DANGER OF THE EGYPTIAN GOVERNMENT RENGGING ON ITS ACCEPTANCE OF THE CEASEFIRE. SHE REPLIED IN THE NEGATIVE, AT LEAST FOR THE PRESENT, AND REPEATED THE PROBLEM WITH EGYPTIAN COMMANDERS IN THE FIELD NOT TELLING . 10. MRS. MEITHEN NOTED THAT, IN HER CONVERSATION YESTERDAY WITH THE SECRETARY AND ASST SECRETARY SISCO. SHE HAD DISCUSSED THE PROBLEM OF LACK OF A MECHANISM TO ASSURE A CEASEFIRE. SHE SAW MERIT IN (THEIR SUGGESTION THAT ISRAELI MILITARY COM-MANDERS ON THE SUEZ FRONT, PARTICULARLY WHERE SHOOTING IS GOING ON, MIGHT TAKE THE INITIATIVE TO CONTACT THEIR EGYPTIAN COUNTER-APRTS TO ARRANGE LOCAL TRUCES. SHE GAVE THE IMPRESSION, HOW-EVER, THAT SHE HAD DISCUSSED THIS WITH HER MILITARY COMMANDERS WHO WERE NOT TOO ENTHUSIASTIC WITH THE IDEA SINCE SUCH HEAVY FIGHTING WAS GOING ON. I SUGGESTED THAT IT MIGHT BE WORTH A TRY EVEN IF THE GYPTIANS DID NOT RESPOND SINCE THE EFFORT ITSELF WOULD HELP CERTIFY THE GOI'S BONAFIDES IN WISHING TO HAVE A REAL CEASE-FIRE. MRS. SHE NOTED IN THIS RESPECT THAT SECRETARY GENERAL WALDHEIM WOULD ONLY BE TOO ANXIOUS TO GET HIMSELF AND THE ENTIRE UN INVOLVED. IN THE
