


SUBJECT: U.S. REACTION TO RECOGNITION OF THE PLO'S

UNILATERAL DECLARATION OF STATEHOOD.

2. A NUMBER OF NON-ALIGNED COUNTRIES HAVE ALREADY RECOGNIZED THE NEW "STATE" DECLARED BY THE PALESTINE NATIONAL COUNCIL (PNC) AT ITS NOVEMBER 12-15 CONCLAVE IN ALGIERS. THE MOMENTUM AND PUBLICITY GENERATED BY THESE ACTIONS MAY INCREASE THE PRESSURE ON OTHER ISLAMIC AND NON-ALIGNED COUNTRIES TO FOLLOW SUIT. ALTHOUGH SOME


GOVERNMENTS WILL HAVE MADE DECISIONS TO EXTEND RECOGNITION, OTHERS WILL BE TAKING A WAIT-AND-SEE ATTITUDE. IT IS THESE STATES WHICH WE HOPE TO

UNCLASSIFIED

INFLUENCE. ALL ACTION ADDRESSEES, OTHER THAN ARAB CAPITALS, WHOSE HOST GOVERNMENTS HAVE NOT YET RECOGNIZED THE STATE ARE REQUESTED TO MAKE REPRESENTATIONS ON THE SUBJECT ASAP. BACKGROUND ON THE RESULTS OF THE PNC IS BEING SENT SEPTEL. BELOW ARE POINTS ELABORATING OUR POSITION ON THE NEW STATE, FOR USE AS APPROPRIATE ALONG WITH PRESS GUIDANCE IN REFTELS.

PNC'S DECLARATION OF INDEPENDENCE - TALKING POINTS

- - PROMOTING MIDDLE EAST PEACE HAS BEEN A TOP FOREIGN POLICY PRIORITY OF THE U.S. AND MANY OTHER STATES.
- - SUCH PEACE IS ONLY POSSIBLE THROUGH NEGOTIATIONS WHICH TAKE INTO ACCOUNT THE LEGITIMATE RIGHTS AND INTERESTS OF ALL PARTIES.
- - THIS HAS BEEN THE FOUNDATION UNDERLYING U.S. POLICY, AND IS THE REASON FOR OUR STRONG SUPPORT FOR UN SECURITY COUNCIL RESOLUTIONS 242 AND 338, WHICH ARE, AFTER ALL, THE ONLY UNIVERSALLY ACCEPTED BASIS FOR MIDDLE EAST PEACE.
- - THOSE RESOLUTIONS CONTEMPLATE THE RESOLUTION OF THE ARAB-ISRAELI DISPUTE THROUGH NEGOTIATIONS.
- - IN KEEPING WITH THAT APPROACH, THE USG HAS CONSISTENTLY OPPOSED EFFORTS BY EITHER ISRAEL OR BY THE





ARABS TO RESOLVE UNILATERALLY THE FINAL STATUS OF THE WEST BANK AND GAZA.

- - A DECLARATION OF INDEPENDENT POLITICAL STATEHOOD IS SUCH A UNILATERAL ACT.
- - FOR THAT REASON, THE U.S. CANNOT SUPPORT THE DECLARATION OF AN INDEPENDENT PALESTINIAN STATE MADE IN ALGIERS AND HOPES THAT OTHER STATES WILL SHARE OUR POSITION.
- - THE SIMPLE REALITY OF THE SITUATION IN THE MIDDLE EAST IS THAT FOR PEACE TO WORK, ARABS AND ISRAELIS MUST SIT DOWN TOGETHER AND WORK OUT AN ACCOMMODATION ACCEPTABLE TO BOTH.



- - WHEN THESE TALKS BEGIN, THE PALESTINIANS ARE FREE TO BRING WHATEVER POSITIONS THEY CHOOSE TO THE NEGOTIATING TABLE.
- - THE DECISIONS EMANATING FROM THE PALESTINE NATIONAL COUNCIL, WHEN COMPARED WITH PREVIOUS SUCH CONCLAVES, INDICATE THAT THERE ARE PNC MEMBERS ATTEMPTING TO STEER THE MOVEMENT IN A POSITIVE DIRECTION THAT'S ENCOURAGING AND SHOULD CONTINUE.
- - BUT MORE NEEDS TO BE DONE TO MOVE FROM PRONOUNCEMENTS AND DECLARATIONS TO CREATING REAL CONDITIONS FOR NEGOTIATIONS.
- - IN ADDITION TO THESE PRACTICAL AND POLITICAL CONSIDERATIONS, THERE ARE ALSO IMPORTANT LEGAL REASONS FOR OUR POLICY OF NON-ACCEPTANCE OF A PALESTINIAN STATE -- AN ENTITY MAY QUALIFY AS A STATE ONLY IF IT HAS A DEFINED TERRITORY AND PERMANENT POPULATION, A GOVERNMENT THAT CONTROLS THAT TERRITORY AND POPULATION, AND THE

CAPACITY TO ENGAGE IN FORMAL RELATIONS WITH OTHER SUCH ENTITIES.

- - A STATE CANNOT EXIST WHERE IT IS NOT REPRESENTED BY A GOVERNMENT WHICH CAN CLAIM EFFECTIVE CONTROL OF TERRITORY OR POPULATION -- THE PNC DID NOT CONSTITUTE A GOVERNMENT FOR THE NEW "STATE."
- - EVEN WERE IT TO DO SO, SUCH A GOVERNMENT CLEARLY COULD NOT CLAIM EFFECTIVE CONTROL OF ANY TERRITORY OR POPULATION, HOWEVER WELL DEFINED.
- - WE CONTINUE TO BELIEVE THAT THE BEST HOPE FOR PEACE LIES IN A NEGOTIATED SETTLEMENT, BASED ON RESOLUTIONS 242 AND 338, WHICH WILL REALIZE THE LEGITIMATE POLITICAL RIGHTS OF THE PALESTINIAN PEOPLE AND ASSURE THE SECURITY OF ALL STATES IN THE REGION. PALESTINIANS SHOULD PARTICIPATE IN EVERY STAGE OF THE NEGOTIATIONS LEADING TO SUCH A SETTLEMENT.
- - IT IS IMPORTANT TO KEEP THE FOCUS ON CREATING THE PRACTICAL CONDITIONS FOR NEGOTIATIONS AND PEACE, AND NOT TO LET OURSELVES BE CARRIED AWAY WITH DECLARATIONS WHICH DO NOT, IN FACT, MOVE US CLOSER TO THIS COMMON GOAL. SHULTZ
