1. INTRODUCTION

The Report to Congress on Voting Practices in the United Nations was first published in 1984, for the year 1983 pursuant to Public Law 98-151 and Public Law 98-164. This year's report is submitted in accordance with section 406 of the Foreign Relations Authorization Act, Fiscal Years 1990 and 1991 (Public Law 101-246 (22 U.S.C. §2414a)).

The UN Security Council (UNSC) and the UN General Assembly (UNGA) are arguably the most important international bodies in the world, dealing with threats to peace and security, disarmament, development, humanitarian relief, human rights, the environment, and narcotics— all of which directly affect major U.S. interests. This report reviews voting practices in the UNSC and the UNGA in calendar year 2022, covering parts of Session 76, Session 77, and Emergency Special Session 11 of the General Assembly, and presents data in a variety of formats. The report summarizes the actions of the UNGA and the UNSC (Section I). All UN Security Council resolutions and votes for the calendar year are described and voting on them is tabulated (Section II). The report statistically measures the overall voting of UN member states at the General Assembly in comparison with the U.S. voting record (Section III). It also lists and describes UNGA resolutions selected as particularly important to U.S. interests (Section IV). The report then presents voting patterns on General Assembly resolutions relating to Israel (Section V). Finally, the report lists a side-by-side analysis for every country according to their respective UN regional grouping (Section VI).

Voting coincidence provides the "comparison of the overall voting practices in the principal bodies of the United Nations" requested by Congress. The UN acts on many diverse issues, therefore, the voting record of a UN member during the General Assembly and Security Council provides insight into a country's orientation in world arenas. Voting coincidence refers to a comparison with the voting record of United States and only within the UN General Assembly and Security Council. It does not account for support for U.S. policy in other bodies in the UN System, other multilateral fora, or bilateral contexts. Most bodies in the UN system adopt resolutions by consensus without votes being taken. In contrast, General Assembly resolutions can require a vote, in part due to the political nature and non-binding aspect of General Assembly resolutions. Overall voting correlation between countries is dependent on the types of resolutions that come to a vote. For example, Israel-related resolutions account for approximately 15 percent of resolutions that are adopted with a vote, significantly affecting the voting coincidence for countries that oppose these resolutions. Approximately 73 percent of all resolutions, however, are adopted by acclamation. While it is difficult to infer specific positions from resolutions adopted by acclamation, it suggests insights into areas of general agreement among member states of the UN. For this reason, the report also provides limited information on how these resolutions figure into voting coincidence.

SUMMARY: UN GENERAL ASSEMBLY

Overall Voting Coincidence: The average voting coincidence for contested resolutions (i.e., requiring a roll-call vote, instead of being accepted by consensus

without a vote) between the United States and the other 192 countries in the UN General Assembly was 48 percent for 2022, a seven-point percent increase from 2021, and higher than the 20-year average of 34 percent.

Allies and Adversaries: In 2022, Israel had the highest voting coincidence with the United States (91 percent), and Syria had the lowest (20 percent). The 10 countries with the highest voting coincidence with the United States were, in descending order from the highest down: Israel, Canada, the United Kingdom, Liberia, Hungary, Australia, Micronesia, Czechia, the Marshall Islands, and France. The 10 countries with the lowest voting coincidence with the United States were, in ascending order from the lowest up: Syria, Nicaragua, Iran, DPRK, China, Cuba, Belarus, Algeria, Bolivia, and Russia.

Contested: Of the 335 draft UNGA resolutions in 2022, 89 draft resolutions (27 percent) were contested and required a vote, compared to 86 draft resolutions (26 percent) during 2021. There were no plenary resolutions that failed to be adopted in 2022, although some failed to be adopted during the committee stage. The number of roll-call votes on UNGA resolutions is higher than in most other international fora, where resolutions are traditionally adopted by consensus.

U.S. Opposition: In 2022, the United States voted against 53 percent of voted UNGA resolutions (which represents 27 percent of all resolutions), the most of any other UN member state besides Israel. Israel also voted against 53 percent of voted UNGA resolutions in 2022. UN member states voted on average,

against eight percent of resolutions in 2022. The United States voted against the most resolutions in 2021 (59 percent) and 2020 (69 percent).

U.S. Isolation: Unlike previous years, the United States never voted in full isolation in any vote in 2022. The United States voted in near isolation on six votes, joined solely by Israel. Those six resolutions were related to development, Cuba, Israeli and Palestinian issues, and issues of self-governance.

Non-votes and Abstentions: The average non-vote/absentee rate for all member states was 10 percent of votes in 2022, a slight increase from the 9 percent in 2021. The country with the most absences was Venezuela, which missed all 89 votes due to being in arrears in its payments to the UN. Sixty-nine member states were present for all 89 votes. In 2022, 11 percent of all recorded votes by all member states in the General Assembly were abstentions. The United States abstained on 10 percent of voted resolutions (nine votes)



SUMMARY: UN SECURITY COUNCIL

In 2022, in addition to the five permanent members – the People's Republic of China (PRC), France, the Russian Federation, the United Kingdom, and the United States – the UN Security Council (UNSC) was composed of the following non-permanent rotating members: Albania, Brazil, Gabon, Ghana, India, Ireland,

Kenya, Mexico, Norway, and the United Arab Emirates. During 2022, the Security Council held 292 public and private meetings, adopted 54 resolutions, and issued seven presidential statements. The Security Council considered 49 agenda items.

In addition to regular meetings, the Security Council held 127 consultations, eleven of which were held with troop-and police-contributing countries (TCCs/PCCs). The top three topics discussed were: Syria (40 times), Sudan/South Sudan (24), and Libya (15).



VOTING COINCIDENCE

There were 61 votes in the UNSC during 2022, with 36 unanimous votes adopting resolutions and 25 votes being contested, having abstentions, or voted down/vetoed. The Security Council adopted a total of 54 resolutions, with seven resolutions failing adoption. The United States voted in favor of 57 draft resolutions, abstained on two, and voted against two (along with the UK and France.)

The graph below compares the 2022 UNSC members' voting coincidence with the United States on the 61 UNSC votes and the 89 UNGA votes. Overall voting coincidence in the UNSC was significantly and consistently higher than in the UNGA, due to the risk of a veto by a permanent member (i.e., P5), which

required thoroughly negotiated compromise language in draft resolutions before they are adopted. This level of compromise was not required in the UNGA due to the one-country one-vote system and lack of a veto.



FORMAT AND METHODOLOGY

The format and presentation of this report are consistent with provisions in Public Law 101-246. During the past year, the Bureau of International Organizations began utilizing tools to better incorporate data analytics into the Department's work. The methodology includes calculations on abstentions and non-votes, and this report gives non-votes the same value as abstentions. The methodology also emphasizes the votes taken on final resolutions over those taken on preliminary texts, and it is intended to capture more accurately the voting conduct of UN member states. The tables in this report reflect country "voting coincidence" with the United States based on all recorded final plenary votes in either the UN General Assembly or Security Council. This computation excludes resolutions approved by consensus (without a vote), procedural motions, preliminary votes, or votes on which either the United States or the country with which it is being compared did not cast a vote (absentee). To provide additional context, the report also includes an additional percentage on voting coincidence for all resolutions adopted by the General Assembly, whether by vote or by consensus, to indicate the range of issues on which common agreement exists. This figure is denoted in the column charts under the heading "All Resolutions."

The **methodology** for calculating the "voting coincidence" compares how the United States and the listed country voted. Votes are placed into one of four categories: same; opposite; partial; and absent.

- "Same" is the total number of times the United States and the listed country voted together, with each vote counting as one (1) point.
- "Opposite" is the total number of times the United States and the listed country voted counter to each other; each vote counts as zero (0) points.
- "Partial" is the number of times the United States and the listed country were partially aligned (one country, but not both, abstained on a resolution), each vote is a half point (0.5).
- "Absent" is the number of times the listed country did not vote. Each absent vote is calculated as a half point (0.5).

Voting Coincidence with the United States is calculated by adding the points, and the total is divided by the total number of votes. For resolutions adopted by acclaim, the vote of every country is assigned "same" and calculated accordingly.

Final plenary votes are decisions on full resolutions, and in this report correspond to the resolutions adopted "with a vote." Preliminary votes are decisions on an operative or preambular paragraph of a resolution. Resolutions can sometimes feature as many as a dozen paragraph votes. Such votes are taken in advance of the final plenary action, and in previous versions of this report, these preliminary votes were combined with final plenary votes in calculating voting coincidence. This practice had the effect of distorting the overall voting coincidence. This distortion stemmed from the repetitive nature of preliminary votes, which may or may not correspond with a member state's

ultimate position on the final plenary vote and inadvertently multiply the relative significance of these resolutions on the voting coincidence metric by the number of paragraph votes. The voting coincidence methodology on contested resolutions in this report only measures a country's final position on a resolution against the final position of the United States. There were 89 roll call votes in the UN General Assembly in 2022, higher than the 86 roll-call votes in 2021 and lower than the 100 in 2020.

Abstentions ("abstain" votes) are included in coincidence metrics for a more comprehensive review and to better measure the shifting support of countries. Solitary abstentions are provided in a new column titled "partial," identifying either the select country or the United States as having abstained on a vote. While reports prior to 2017 ignored abstentions, counting single abstentions with a half-point provides more nuance to the voting coincidence metric. Convincing a country to shift its vote from opposite the U.S. position can take significant effort or involve significant political cost if the country is breaking the consensus position in a regional group or ideological voting bloc. Convincing a country to abstain can be an incremental step toward an eventual reversal or, depending on the overall votes, be a successful or useful outcome in itself.

Non-votes/Absences are now included in voting coincidence calculations since a country's absence can often be political (purposely not attending) as much as situational (unable to attend). Like abstentions, persuading a country to consciously not vote rather than oppose a U.S. position also takes significant effort and often provides a pathway for countries to act without alienating a

regional or ideological voting bloc. Consequently, non-votes are scored as abstentions. Non-vote/Absentee counts are provided separately in the "absent" column. In 2022, a few countries were absent for all votes on Israel-related or "important" issues (defined below), or both. A country's absence may also be apolitical. Countries may be absent due to their mission to the UN's lack of capacity. In a few cases, countries have been barred from voting due to being in arrears in payments to the UN. In keeping with this report's methodology, these countries are given the same value as abstain, but their true voting alignment with the United States remains unknown.

Consensus resolutions have been excluded (since 1984) from the main voting coincidence metrics, except for the general voting metric noted above.

Resolutions adopted by recorded vote address issues of contention more

explicitly and are more revealing about whether countries support U.S. positions or oppose them, which is why they were the original focus of the 1984 report. Because the UNGA adopts between 70 and 80 percent of its resolutions by acclaim, excluding assessment of consensus resolutions oversimplifies the measure of opposition to U.S. positions, and understates areas of general agreement. Thus, this report follows the existing methodology of previous reports, but now also includes an additional general figure for overall coincidence as well (see charts pages 52-61.) In 2022, there were 246 consensus resolutions in the UN General Assembly, a slight decrease from the 248 in 2021 and a large increase from the 209 in 2020.

Important issues are defined in the U.S. Department of State's annual U.S. Congressional Report on "Voting Practices in the United Nations" and by Public Law 101-246 which calls for, with respect to plenary votes for the UN General Assembly, a listing of "votes on issues which directly affected important United States interests and on which the United States lobbied extensively." An essential basis for identifying "important" issues is their alignment with the State Department's Strategic Goals.

Israel_related issues are identified by any resolution specifically mentioning the state or territory of Israel. The titles and context of these resolutions usually remain the same each year, with an annual average of 13-17 one-sided, biased resolutions against Israel (compared to an average of about a dozen country-specific resolutions on the rest of the world combined).

COUNTRY NAMES

This report uses official United Nations membership country names since this report is based on United Nations data and requires ability to cross reference this report with official voting records from the United Nations. Due to page formatting limits, some tables may use short form or officially assigned International Organization for Standardization (ISO) 3166-1 alpha-3 codes. The use of any country's name in this report does not represent official recognition by the United States or indicate any shift in U.S. policy.

2. SECURITY COUNCIL

In 2022, the Security Council considered 61 resolutions, adopting 54 and failing to adopt seven draft resolutions. Of the 61 votes on resolutions, the United States voted in favor of 57, voted against two, and abstained on two. Russia vetoed four of the failed resolutions and the PRC joined Russia in one of the vetoes. France and the United Kingdom did not exercise their veto. The table on page 24 lists the resolutions of the UN Security Council and voting outcomes.

SIGNIFICANT EVENTS

In 2022, the Council held 292 public and private meetings, with 23 held at a
high-level, a decrease in comparison to 2021. The UNSC discontinued use
of high-level videoconferences in 2022, leading to an overall decrease in
the number of meetings. Nevertheless, high-level participation by member
states was evident, as seen during the September 22 meeting on the

- "Maintenance of peace and security of Ukraine," where all 15 Council members were represented at the ministerial level or higher.
- Throughout 2022, the Council unanimously adopted several important resolutions. On February 22, the Council adopted resolution 2621, which decided that the United Nations Compensation Commission had fulfilled its mandate to administer a fund to pay compensation for direct loss, damage, or injury as a result of Iraq's unlawful invasion of Kuwait.
- On February 27, the Council referred the Situation in Ukraine to the
 General Assembly using a procedural vote (Resolution 2623 (2022)). Russia
 voted against the measure; however, because the vote was procedural in
 nature, a veto by a permanent member does not apply and the Council still
 referred the situation to the UNGA. This report therefore tracks this
 decision as a voted resolution.
- On March 31, the Council adopted resolution 2628, which endorsed the
 decision of the African Union Peace and Security Council to reconfigure the
 African Union Mission in Somalia into the African Union Transition Mission
 in Somalia.
- On May 31, the Council adopted resolution 2634, which urged Member
 States in the region of the Gulf of Guinea to develop and implement
 national maritime security strategies, including for the establishment of a
 harmonized legal framework for the prevention and repression of piracy
 and armed robbery at sea.

- On October 21, the Council adopted resolution 2653, which established a new sanctions regime in connection with Haiti, imposing sanctions measures consisting of a travel ban, asset freeze and targeted arms embargo, and establishing a four-person Panel of Experts and Committee to oversee the measures.
- On November 30, the Council extended the mandate for another ten years
 of the 1540 Committee regarding the non-proliferation of weapons of
 mass destruction until November 30, 2032, with resolution 2663.
- On December 9, the Council adopted resolution 2664, which established a
 humanitarian carve out to the asset freeze measures across UN sanctions
 regimes. This landmark initiative is easing the delivery of vital
 humanitarian assistance to those in need while maintaining sanctions on
 designated actors and mitigating the diversion of assistance thereto.
- On May 6, the Council issued a presidential statement (S/PRST/2022/3)
 expressing deep concern regarding the maintenance of peace and security
 of Ukraine and strong support for the efforts of the Secretary-General in
 the search for a peaceful solution.

UNSC Vetoes: The United States did not exercise a veto in 2022. Russia exercised four vetoes on resolutions regarding Russia's sham referenda, the territorial integrity of Ukraine, Syria's humanitarian cross-border mandate renewal, and DPRK Nonproliferation (additional sanctions in response to ICBM test), and the PRC exercised one veto on DPRK Nonproliferation (additional DPRK sanctions in response to a series ICBM test). The United Kingdom and France exercised no vetoes.

Table 7: 2022 Voting Coincidence With The United States on Security Council Votes

The following table summarizes UN member state voting coincidence with the United States for the 61 votes in 2022, sorted from highest to lowest. The methodology for obtaining the figures is in Section I. Voting coincidence in the UNSC is significantly and consistently higher than in the UNGA, due to the risk of a veto by a permanent member (i.e., P5), which requires member states to thoroughly negotiate compromise language in order to secure adoption. This level of compromise is not required in the UNGA due to the one-country one-vote system and lack of a veto.

3. GENERAL ASSEMBLY: ALL ACTIONS

Public Law 101-246 calls for a listing of all UN General Assembly (UNGA) votes. For 2022, 89 draft resolutions are included in this section; there were no draft resolutions that failed adoption. Of the 89 draft resolutions requiring a vote, the United States voted in favor of 33, opposed 47, abstained on nine, and was present for all 89 votes. The following resolutions are identified by a resolution number, short title, how the United States voted, and final vote tally.

4. GENERAL ASSEMBLY: IMPORTANT ACTIONS

Public Law 101-246 calls for a listing of important UN General Assembly (UNGA) votes, defined as "votes on issues which directly affected important United States interests and on which the United States lobbied extensively." An important basis for identifying issues is their alignment with the State Department's Strategic Goals. For 2022, 30 resolutions were identified for inclusion in this section; nine were adopted without a vote because the United States was able to achieve consensus language through lobbying and engagement. The General Assembly adopted the remaining 21 with a vote. Of these 21 important resolutions, the United States

voted in favor of 15, opposed five, abstained on one, and missed no votes. The following resolutions are identified by a short title, resolution number, vote tally (Yes-No-Abstain or "without a vote"), and how the United States voted. Below is a summary analysis of the important elements of the identified resolutions, grouped by general category.

UKRAINE: The United States supported several important resolutions in condemnation of Russia's full-scale invasion of Ukraine. These included:

- Aggression against Ukraine (General Assembly Resolution Number A/RES/ES-11/1),
- Humanitarian consequences of the aggression against Ukraine (A/RES/ES-11/2),
- Territorial integrity of Ukraine (A/RES/ES-11/4),
- Situation of human rights in the temporarily occupied Autonomous Republic of Crimea and the city of Sevastopol, Ukraine (A/RES/77/229), and
- Suspension of the rights of membership of the Russian Federation in the Human Rights Council (A/RES/ES-11/3).

HUMAN RIGHTS: Important human rights resolutions included those that addressed the human rights situations in:

- Myanmar (A/RES/77/227),
- Iran (A/RES/77/228),
- Crimea and Ukraine (A/RES/77/229),
- DPRK (A/RES/77/226), and
- Syria (A/RES/77/230).

The United States co-sponsored these resolutions and lobbied extensively to ensure that these texts reflected the dire situation of human rights in these countries.

DEVELOPMENT: The United States engaged heavily on resolutions including:

- International trade and development (A/RES/77/151), international financial systems and development (A/RES/77/152),
- the eradication of rural poverty under the 2030 Agenda for Sustainable Development (A/RES/77/183), and
- partnership for African development (A/RES/76/297)

Unlike in past years, the UN General Assembly voted on resolutions (A/RES/77/151) and (A/RES/77/152) which focused on trade and international financial systems. In support of the independence and integrity of the UN

system, we voted against the resolution on rural poverty, in part due to language reflecting the domestic policies and political ideology of a single member state that were not appropriate in a UN resolution.

ARMS CONTROL, CYBER, AND NUCLEAR: Important conventional arms control resolutions included:

- A/RES/77/71,
- A/RES/77/61, and
- A/RES/77/62.

A/RES/77/41 encouraged countries not to conduct destructive, direct-ascent anti-satellite missile tests. Nuclear weapons- and nonproliferation-related resolutions included:

- A/RES/77/38,
- A/RES/77/54,
- A/RES/77/76, and
- A/RES/77/94.

5. GENERAL ASSEMBLY: ISRAEL-RELATED ACTIONS

Public Law 101-246, as amended by Public Law 108-447, calls for a listing of all General Assembly plenary votes cast on resolutions specifically related to Israel. This section includes: 1) a listing of Israel-related votes; and 2) voting coincidence percentages with the United States. The annual resolutions condemning Israel are repetitive, disproportionate, one-sided, and do not acknowledge that all parties to the conflict bear direct responsibility for ending it.

During 2022, the General Assembly considered 14 Israel-related resolutions and adopted all of them. Of these 14 resolutions, 13 resolutions were adopted by roll-call vote. One was adopted by consensus. The United States voted against 12 of these resolutions and Israel voted against those not adopted by consensus. Of 193 UN members, 36 voted against at least one of these resolutions at least once, 16 more than in 2021.

Twenty countries (Costa Rica, San Marino, Kenya, Democratic Republic of the Congo, Togo, Papua New Guinea, Sweden, Denmark, Greece, Netherlands, Switzerland, Italy, Lithuania, Chad, Slovakia, Bulgaria, Croatia, Romania, Estonia, Germany, Albania) joined the list of countries that voted against at least one of these resolutions at least once, while four (Colombia, Dominican Republic, Honduras, and Philippines) dropped off this list. In both 2022 and 2021, 13 percent of Israeli-Palestinian roll-call votes were abstentions. Ninety-eight countries abstained on Israel-related resolutions at least **once** in both 2022 and 2021.

6. GENERAL ASSEMBLY: REGIONAL GROUPS

Originally, UN member states were unofficially grouped into five geopolitical regional groups. What began as an informal means of sharing the distribution of posts for General Assembly committees has taken on a much more expansive role. Depending on the UN context, regional groups may control elections to UN-related positions based on geographic representation, as well as coordinate substantive policy and form common fronts for negotiations and voting. The methodology for obtaining the "voting coincidence" can be found in Section I of this report.
