THE STRUGGLE FOR PALESTINE: THE ROOTS OF THE ARAB-ISRAELI CONFLICT

I. <u>Course Description:</u>

This course introduces students to the initial stages of the Arab-Israeli conflict, starting from the first waves of Zionist immigration to Palestine through the 1948 war and the establishment of the state of Israel. It will focus on the emerging features of the conflict, the struggle between the Palestinian Arab and Jewish Nationalist movements, and the international involvement in these events. A variety of scholarly studies will provide the background for class discussions. The course will focus on the emergence of the Zionist and Palestinian nationalist movements, British policy in Palestine, the rise of new Zionist and Palestinian leaders, the 1936-1939 Arab Revolt, and the post World War II efforts to establish a Jewish state. Our focus on these events will be linked to broader regional developments in the Middle East, which also play a role in the struggle for Palestine. These include the breakup of the Ottoman Empire, the rise of Arab nationalism, and the modern Arab state system that emerged in the inter-war period. This backdrop links the discussion of the roots of the Arab-Israeli conflict to the wider realm of Middle East studies, and expands this course's scope of inquiry. Understanding the roots and history of this conflict is important for students at USNA, many of whom are likely to serve in the Middle East at some point in their military career.

II. Course Requirements and Rules:

Homework, Quizzes and Class Participation: Students must come to class ready to discuss the day's assigned readings and topics. The method of instruction in this course is lecture and discussion based, so each and every student should expect to participate in the active learning process. Your performance during in-class discussions, on quizzes and on homework assignments (assigned periodically by the professor) will directly affect your grade in this course. (20 points) <u>Exams</u>: There are two exams in this course, a Midterm, and a Final (date TBD). Format may include vocabulary, text comprehension and identifications; short answer; multiple choice, and essay questions. Questions for the exams will be drawn from course readings, lectures, and current events. Students who actively participate in class and take liberal notes will do better on the exams. (Midterm= 30 points; Final=30 points)

<u>Research Paper</u>: Every student in this course is to write a 10-15 page research paper. Each student will turn in a <u>research paper proposal</u> which the professor must approve. (Proposal due in class March 28, 2013).

The final draft is due on April 25, 2013 . (20 points final draft). (Students are encouraged to form research paper review teams to get peer feedback on their written work; the professor is also willing to read rough drafts)

Note***** Plagiarism: All research papers must display original thought and writing. Papers written for other courses taken in the past or concurrently are strictly forbidden as is material taken from other sources and passed off as your own. This is plagiarism, a form of cheating that is clearly an honor violation.
