## **History of Zionism and the State of Israel**

Israel is the outcome of an ideological movement that creates a community, which became a state. The movement, the community and the state will be the aims of this course.

#### Course description

The course will offer a historical introduction accompanied by a sociological analysis of the Zionist movement, the early settlement or 'Yishuv' and the first 50 years of the State of Israel. The first part of the course will be devoted to the emergence of Zionism, the ideologies of its early leaders, and the relationship of the Yishuv to internal Zionist debates and external powers. In the second part of the course, we will discuss The creation of the State; the Arab-Israeli conflict; the political system; the mass immigration and the ethnic gap; and relations with the Arab minority and the question of Identity.

#### Requirements:

Attendance: Students must attend all classes. Class attendance is recorded. Student with more than four unexcused absences will have there final grate lowered.

<u>Participation</u>: Students are expected to come to class prepared to discuss the assigned readings as well as current events concerning Israel. Questions, discussion and debate during class are strongly encouraged.

<u>Midterm Exam</u>: The in-class, mid-term exam will consist of short-answer questions (multiple choice, true/false, explain the terms, etc.) based upon the topic we have covered up to that point.

<u>Final quiz</u>: Like the midterm exam, based upon all the semester's topics.

The purpose of those exams is to check student's reading, knowledge and understanding of the course materials.

Research Paper: Student will choose a subject to research and write about. The subject and the recearch question must be approved by me. The paper should be based upon at least 5 scholarly sources and should be approximately 10 pages, written according to proper academic rules. The purpose of this paper is to practice your writing skills and to specialize in one subject.
